

## SECTION 1 — IDENTIFICATION

## SECTION 2 — HAZARD(S) IDENTIFICATION

The toxicological properties of this material have not been fully characterized. Not classified under 29 CFR 1910.1200 based on available data; treat as potentially hazardous. Avoid inhalation of dust, skin/eye contact, and ingestion. Research use only by qualified personnel.

## SECTION 3 — COMPOSITION / INFORMATION ON INGREDIENTS

Glutathione — synthetic peptide, lyophilized powder. CAS 70-18-8. Sequence/identity:  $\gamma$ -Glu-Cys-Gly (reduced, GSH). May contain residual counter-ions (e.g., trifluoroacetate) and moisture typical of lyophilized peptides.

## SECTION 4 — FIRST-AID MEASURES

**Inhalation:** remove to fresh air; seek medical attention if symptoms occur. **Skin:** wash with soap and water. **Eyes:** flush with water  $\geq 15$  minutes; seek medical attention. **Ingestion:** rinse mouth; do NOT induce vomiting; seek medical attention. Show this SDS to medical personnel.

## SECTION 5 — FIRE-FIGHTING MEASURES

Not flammable as supplied. Extinguish with media suitable for surrounding fire (water spray, CO<sub>2</sub>, dry chemical, foam). Combustion may produce oxides of carbon and nitrogen. Firefighters should wear self-contained breathing apparatus.

## SECTION 6 — ACCIDENTAL RELEASE MEASURES

Wear PPE per Section 8. Avoid dust generation. Sweep or wipe up material and place in a suitable closed container for disposal. Wash the spill area with water. For solutions, absorb with inert material.

## SECTION 7 — HANDLING AND STORAGE

Handle per good laboratory practice; avoid dust formation. Store lyophilized at  $-20^{\circ}\text{C}$ , protected from light and moisture. Reconstituted solutions: use per laboratory protocol; store refrigerated and label with date.

## SECTION 8 — EXPOSURE CONTROLS / PERSONAL PROTECTION

No occupational exposure limits established. Use local exhaust or fume hood when handling powders. **PPE:** nitrile gloves, safety glasses, lab coat. Wash hands after handling. Do not eat, drink, or smoke where handled.

White to off-white lyophilized powder; odorless. Soluble in aqueous buffers per laboratory practice. Molecular weight 307.32 g/mol.

Stable under recommended storage conditions. No hazardous polymerization. Incompatible with strong oxidizers, strong acids/bases. Avoid repeated freeze-thaw of reconstituted solutions.
